

CONTRACT AND BILL OF SALE

Jonathan Paranjothy, Windy City Spinoni agrees to sell one Spinoni male/female puppy, Windy City _____ whelped December 13, 2003 for \$ _____

This litter will be registered with both NAVHDA and FDSB; the puppy will be registered with NAVHDA. The registration number is SP _____. The FDSB Litter registration is _____. This puppy has been permanently identified with an Animal Recovery micro chip # _____.

Registration papers will be with held by the seller for the purpose of assuring the, and until the following conditions are met.

1. The pup is tested with NAVHDA or an agreement acceptable to the seller is made.
2. The pup is X-rayed for canine hip dysplasia and the X-ray is diagnosed by the Orthopedic Foundation for Animals (OFA) or Penn Hip and a photocopy of the result is given to the seller.

The buyer is completely responsible for the care and management of the pup from the time of delivery.

PUPPY GUARANTEE

1. The dog is a purebred Spinoni; a correct pedigree will be given to the buyer. When the above conditions are met, the dog's registration will be transferred to the buyer, unless a severe hereditary defect appears.
2. The puppy is healthy. At the option and expense of the buyer, the puppy should be taken to a veterinarian within 48 hours of purchase. If the puppy is found to be unhealthy, the buyer will receive a 100% refund, providing the dog is returned immediately to the seller. This does not include conditions that are the result of the buyer's negligence or accidental occurrences.
3. The dog is free of detectable hereditary crippling defect up to 26 months of age. If such defects should appear, one of the following will apply, at the discretion of the seller.
 - a. Full replacement of the pup from the next available litter, provided the pup is immediately returned to the seller at the buyer's expense. The buyer must provide the seller with acceptable verification of said defect.
 - b. The buyer may keep the pup and receive half off the next purchase of a pup from the next available litter. The buyer must provide the seller with acceptable verification of said fault and confirmation that the dog has been neutered/spade and properly treated for said fault. Some serious hereditary faults if properly treated will not render the dog unfit to hunt. Since a great deal of time, money and emotion will have been invested in the puppy by the buyer.
4. This puppy has been carefully socialized and shows no temperament problems at the time of sale.
5. Along with your puppy, you will receive a copy of "THE CARE AND TRAINING OF THE VERSATILE HUNTING DOG" and of the NAVHDA AIMS AND PROGRAMS and TEST RULES to assist the buyer in the training and handling of his new dog.
6. The seller cannot be responsible for the handling and development of the dog.

Should this dog be determined to be breedable WINDY CITY SPINONI reserves the right to 3rd pick puppy at no charge from every litter produced by this female named above or one free stud service from this male named above.
